

EDUCATIONAL COUPON CODE TERMS

Automatic Tutorial Maker

1. PURPOSE

These terms establish the conditions under which Octanta Studio provides the Educational Institution with a coupon code for the free distribution of the Automatic Tutorial Maker asset ("Asset") to its students.

The Asset is officially listed on the Unity Asset Store at

<https://assetstore.unity.com/packages/tools/utilities/automatic-tutorial-maker-create-customizable-learning-steps-by-s-310196> for \$40. As the original author and copyright holder of this Unity-verified asset, Octanta Studio offers a special distribution model for educational institutions.

2. ASSET DESCRIPTION

2.1 The Automatic Tutorial Maker is a quality Unity asset officially available on the Unity Asset Store for \$40 USD (<https://assetstore.unity.com/packages/tools/utilities/automatic-tutorial-maker-create-customizable-learning-steps-by-s-310196>).

2.2 This asset is developed by Octanta Studio and has been verified by Unity Technologies to meet their quality standards.

2.3 The Asset allows developers to easily create in-game tutorials by simply playing through the desired sequence, with the tool automatically generating visual guidance for players. Manual creation of steps is also possible.

3. TERM

These terms are valid for one (1) year from the Effective Date, after which they may be renewed at Octanta Studio's discretion.

4. COUPON CODE

4.1 Octanta Studio will provide the Educational Institution with a single coupon code in the format similar to "UJ79BYWBHT" via the institution's official email address.

4.2 The coupon code:

- Provides a 100% discount on the Automatic Tutorial Maker asset on the Octanta Studio website
- Is valid for one (1) year from the Effective Date
- Can be used an unlimited number of times during this period
- Is to be used exclusively by students and faculty of the Educational Institution, non-transferable

4.3 As the original author and copyright holder, Octanta Studio has the right to distribute this asset under these special terms.

5. REDEMPTION PROCESS

5.1 Students will:

- Visit octantastudio.com
- Find the section to get the Automatic Tutorial Maker using a coupon
- Apply the coupon code during checkout via PayHip
- Receive the asset at 100% discount (free)
- Receive an email with a direct download link for the asset package

5.2 The asset provided will always be the latest version available on the Unity Asset Store during the one-year coupon validity period.

5.3 Students accept the standard Unity Asset Store End User License Agreement (EULA) when downloading the asset.

5.4 The package received by each student includes:

- Complete Unity package containing the full functionality of the asset (AutomaticTutorialMaker.unitypackage, 779 KB)
- Unity Asset Store EULA license document (269 KB)
- PDF copy of documentation from GitBook (ATM_docs, 11.345 KB)
- Compressed version of the documentation (ATM_docs_compressed, 2.135 KB)
- AI Helper file for LLM assistance (ATM_helper, 42 KB)

5.5 The entire product download is approximately 12 MB in total size.

5.6 Email addresses collected during the checkout process will not be used for spam or marketing campaigns not directly related to the Asset.

6. ASSET USAGE AND OWNERSHIP

6.1 Students who redeem the coupon code receive perpetual usage rights and may:

- Use the Asset in educational projects
- Use the Asset in personal and commercial projects
- Retain access to the Asset indefinitely
- Receive the same rights granted under the Unity Asset Store EULA

6.2 Students may not:

- Redistribute the Asset to others
- Share the coupon code
- Claim authorship of the Asset
- Sell or sublicense the Asset separately from their own projects

6.3 Octanta Studio confirms that:

- The Asset has no built-in expiration date or usage limitations
- Once downloaded, the Asset will never be remotely deactivated or removed
- The current version is an LTS (Long Term Support) version with full functionality

7. EDUCATIONAL INSTITUTION OBLIGATIONS

7.1 The Educational Institution should:

- Share the coupon code only with its students and faculty
- Inform students of these terms of use
- Take reasonable steps to prevent coupon code misuse
- Not publish the coupon code on publicly accessible websites

7.2 The Educational Institution is encouraged to include the Asset in its curriculum for relevant courses.

8. CONTINGENCY PLAN

8.1 In the event of force majeure circumstances where access through octantastudio.com or PayHip becomes impossible due to external factors, Octanta Studio will:

- Upon request from the Educational Institution, provide an alternative distribution method
- This may include, but is not limited to, providing access to a GitHub organization repository containing the Asset
- Make reasonable efforts to accommodate such requests within 10 business days

9. PROMOTIONAL RIGHTS

9.1 Octanta Studio may:

- List the Educational Institution as a partner on its website
- Reference the partnership in marketing materials

9.2 The Educational Institution is encouraged to provide feedback on the Asset's educational value during the term.

10. TERMINATION

10.1 These terms may be terminated:

- By mutual agreement
- By Octanta Studio if the Educational Institution breaches these terms
- Automatically at the end of the one-year term

10.2 Upon termination, the Educational Institution must cease sharing the coupon code, but students who have already redeemed it will retain access to the Asset.

11. LIABILITY

11.1 The Asset is provided "as is" without warranty of any kind.

11.2 Octanta Studio is not liable for any damages arising from the use of the Asset.

12. UPDATES AND DOWNLOADS

12.1 Update availability:

- Asset updates are available to students during the one-year period the coupon code is active
- Students can re-download updated packages from the website using their original download link
- After the coupon expiration date, access to new downloads and updates will be discontinued

- Unlike purchases through the Unity Asset Store, educational license holders do not receive lifetime updates

12.2 Update assurance:

- The current version distributed through the Educational Program is an LTS (Long Term Support) version
- All core functionalities are fully implemented and operational
- The asset will continue to function properly on supported Unity versions, even without updates
